Tournament Schedule:

The doors will be open at 7:00 AM. The coach's meeting will be held promptly at 7:30 AM at each location, with pool play beginning immediately thereafter. At the coach's meeting, final tournament rosters with USAV numbers need to be checked and signed by the coach, pool play information will be distributed, the Day Official will be introduced, ground rules reviewed, and any other issues addressed. The meeting is mandatory and please be on time.

Rosters:

The Evergreen region will be emailing us official rosters the week prior to the tournament. However, unforeseen issues may occur, so make certain you have a back-up roster with the Evergreen Region stamp with you at check-in.

Tournament Play:

Pool play warm ups will begin immediately after the coach's meeting. Initial warm ups will be 5 & 5 with no shared hitting; ALL SUBSEQUENT WARM-UPS WILL BE 3 & 3. Your help in keeping the matches running on time will help keep the tournament on schedule.

Four team pool and tournament play matches will consist of 2 out of 3 sets. The first 2 sets are to 25 points. The 3rd set, if needed, will be to 15 points. In the event a three-team pool develops due to a team dropping out or not showing up, pool play will consist of 3 of 3 sets. Match results will be posted near the tournament desk as matches are completed. Please have your scorekeeper return completed match score sheets to the tournament desk and pick up another set for the following match. COACHES MUST SIGN THE SCORE SHEETS AFTER EACH MATCH

The Championship and Consolation brackets will be set and play will begin immediately upon completion of pool play. The playoff brackets are both single elimination. You will be required to referee the next match on your court if you lose during the playoffs. We will try to have local teams referee if you lose and are a long way from home. However, <u>please do not leave until arrangements are made or without checking with the Site Manager</u> to make sure that you have fulfilled all of your responsibilities.

Awards:

The tournament champion team will receive a t-shirt for each team member. The winner of the Consolation bracket will also receive an award.

Food:

No food will be allowed in any gym without prior approval from the tournament director, this is a USAV rule. Approval will only be granted for medical reasons, and in that situation, must be kept to a minimum. The only liquid allowed in the gyms will be water. NO EXCEPTIONS. Should your team, parents or spectators violate this rule, you team will be assessed an 8 point penalty at the beginning of the next set for the 1st violation. A 2nd violation will result in a 15 point penalty.

The cafeteria outside the gyms will have tables available for teams to set up their food areas. NO CROCK POTS, PLUG-IN APPLIANCES OR GAS OPERATED APPLIANCES ARE ALLOWED. Each team needs to clean up their area before leaving, this includes wiping down tables, sweeping under the tables and putting garbage in cans.

Site Rules & Directions:

No smoking in the school or on the school grounds. No pets inside the school or gymnasium. No warm-up activities in the hallways or cafeteria. No lawn chairs in either gym. Bleachers will be available.

Note: West Valley Schools are all video-taped during the weekend, and reviewed on Monday. Please do not violate any rules or policies -- we would like to keep our gym privileges.

From I-82 North (Ellensburg). Take the N 1st St/US-12 W exit, EXIT 31A/31B, toward Naches. Take EXIT 31A. Merge onto US-12 W. Continue to North 40th Ave Fruitvale Blvd exit. Exit onto 40th Ave. Continue up the hill. Turn right onto W Nob Hill Blvd. Turn left onto S 72nd Ave. Turn right onto Zier Rd. The Freshman Campus will be the first school you see on the left, and the High School is a quarter mile past.

From I-82 South (Yakima, Moxee, lower valley, Tri-Cities). I-82 W/US-12 W/US-97 N. Take US-12 W via EXIT 31 toward Naches/White Pass. Continue to 40th Ave Fruitvale Blvd exit. Exit onto N 40th Ave. Continue up the hill. Turn right onto Nob Hill Blvd. Turn left onto S 72nd Ave. Turn right onto Zier Rd. The Freshman Campus will be the first school you see on the left, and the High School is a quarter mile past.
